A new model I've been using to pay down debt:


Rather than refinancing or taking out a consolidation loan, 5arz pays my qualifying debts to the original creditor up front. I earn the payoff back by completing short tasks (10-15 min each). Each task earns Stars — 1 Star = \$1 off my balance. No interest. No fees.

Average member retires their balance in 12-18 months working a few hours a week. I'm at month 3.

18. The honest disclosure post

[SHARE] Found a debt-payoff platform that actually works — sharing in case useful (yes I have a referral link, will note below)

Been carrying \$6K in credit card debt since college. Tried Tally, then Method, both okay but you still pay interest on the consolidation loan. Tried 5arz two months ago. They pay your creditor up front (no loan, no interest), and you pay them back by doing short tasks on the app (10-15 min each, multiple-choice questions about content quality mostly). Each task earns "Stars" that knock \$1 off your balance.

Numbers from my dashboard: \$312 burned off in week 1, \$580 in month 2. Probably done by month 12 at this pace.

Things I want people to know:

- Not a loan. Not a credit product. They pay your creditor and you pay them back with task work.
- Tasks are easy. You're rating responses, flagging bad content, doing multiple choice. Not coding, not training models manually.
- Their revenue comes from selling the aggregated task data to AI research partners. That's how they fund the upfront debt payoff.
- FTC-compliant. They have proper disclosures.

Voicemail / phone script (if you're old-school cold-calling friends-of-friends)

Hey [name], it's [you], [mutual friend]'s [relation]. Quick reason for calling — I'm running a side gig with a debt-payoff company called 5arz, and your friend [mutual] said you might be carrying some balance you're trying to knock down. Real quick: they pay your creditors directly, you earn it back doing simple tasks at home. No job needed, no interest, no fees. Most people are done in a year. If you want me to text you the link, just shoot me a yes back. No pressure either way. Thanks!

Posting frequency that actually works

- **First week:** 1 Instagram Story per day showing your dashboard burn-down + 1 TikTok per week
- **Group chats:** 1 share in your 3 biggest group chats in week 1, then 1 follow-up per month with a receipt
- **One-on-one DMs:** Hit 20 specific people in week 1 with personalized messages (use #16)
- **Reddit:** 1 post per relevant sub, then engage in comments — don't spam

Top reps make 80% of their direct recruits in the first 30 days via personalized DMs. Cold posts only work after you have receipts to show.

What NOT to say (compliance)

"Guaranteed payoff in X months"

"Average member retires their balance in 12-18 months"

"Free money"

"Earn debt erasure by completing tasks"

"Make \$X this month" (without earnings disclosure)

"Earnings depend on referee activity — see 5arz.com/earnings"

"Better than [competitor name]"

"Here's what I switched to and why"

Keep it honest. The receipts do the work.
